Directions to Veterinary Clinic and Hospital

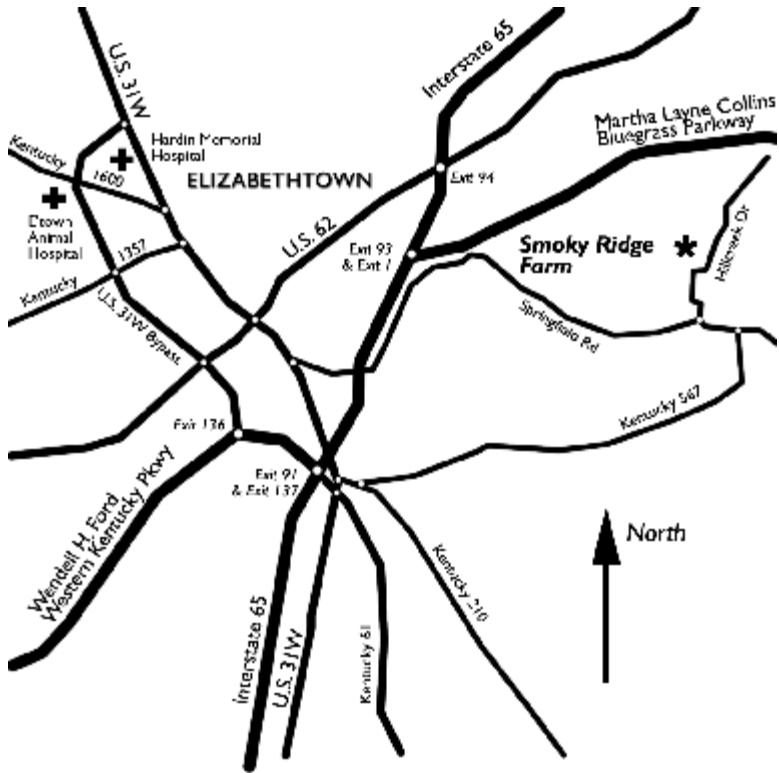
From the trial site to the hospital, turn right out of the driveway and take Hillcreek Drive until it ends. Turn left on Springfield Road, and then right on Kentucky 567 (Valley Creek Road). After about four miles, turn right on Kentucky 210 and then right again on U.S. Route 31W. Take U.S. 31W through town, around the courthouse. Once the road splits into a divided highway, you will see the hospital coming up on your left.

To get to the veterinary clinic, follow the directions above, but just before you reach the hospital, turn left onto Kentucky 1600 (Woodland Drive). Follow Kentucky 1600, as it turns left onto Cardinal Drive. Elizabethtown Animal Hospital is approximately 1/2 mile on the left, just past the bridge over the U.S. 31W Bypass.

Directions to Trial Site

From Louisville or north, take I-65 south. From Nashville or south, take I-65 north. From Lexington or east, take the Martha Layne Collins Bluegrass Parkway west to the end, and then follow the signs to I-65 south. From Paducah and the west, take the Wendell H. Ford Western Kentucky Parkway to the end, and follow directions from there.

From all these places proceed to the Elizabethtown/Hodgenville exit (#91). Follow signs as if you are going to Hodgenville until you get to the first red light, which is U.S. Route 31W (this is also the end of the WK Parkway). Turn left on U.S. 31W and proceed to the next light and turn right, between the Shell and Chevron stations (Kentucky 210). Go about a block and then turn left onto Kentucky 567 (Valley Creek Road). Go straight through the four-way stop sign and continue on about four miles to the Valley Creek Baptist Church. Note the cute lamb in the stained glass window. Turn left at the church onto Springfield Road, and then take the first street on the right, which is Hillcreek Drive. Hillcreek Drive is a winding country road, so be very careful of blind curves. Smoky Ridge Farm is on your left, with the name "Miller" on the mailbox and a sign with a sheep upon it. There is a long red barn, and you will be able to see the course from the road. If you get to the dead end, you've gone too far.
