

Directions to Trial Site

From the Drawbridge Inn in Fort Mitchell, Kentucky

Head southeast on Royal Drive, then turn right (northwest) on Buttermilk Pike.

Turn left and merge on I-71/I-75 south.

Continue south on Interstate 75 towards Lexington for about sixty (60) miles.

Take exit 126 for U.S. Route 62. Keep right at the fork, and merge onto Cherry Blossom Way (U.S. 62).

Turn left (east) on Paris Pike (U.S. 460) and travel approximately ten miles, past Centerville to Elizabeth Station.

Turn left (northeast) on Clay Kiser Road (Kentucky 1876) and travel about 4.5 miles.

Turn left (north) on Cynthiana Road (U.S. Route 27) and go approximately 2.3 miles.

Turn right (east) on Shawhan Road (Kentucky 1893) and travel about 1.8 miles, until you pass a bridge and railroad tracks.

The first road on your left will be Shawhan Lane. The land on your right is where the trials will be held; follow the signs on how to enter!

From Georgetown, Kentucky

Take Paris Pike (U.S. Route 460) east and travel approximately ten miles, past Centerville to Elizabeth Station.

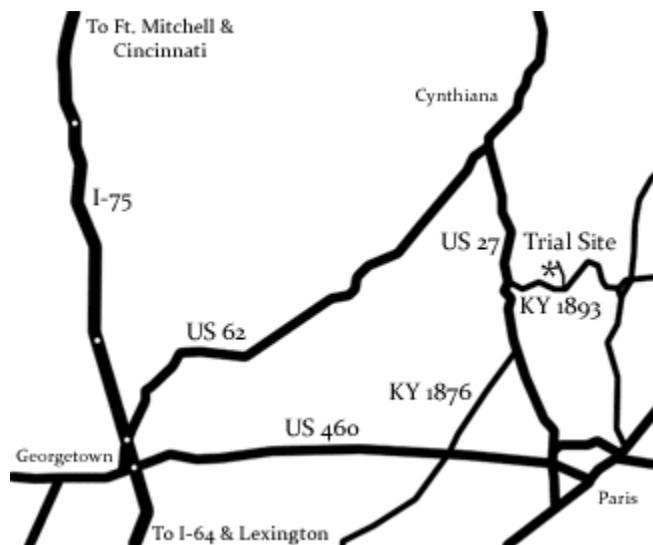
Turn left (northeast) on Clay Kiser Road (Kentucky 1876) and travel about 4.5 miles.

DIRECTIONS TO VETERINARIAN'S OFFICE

From the trial site to the veterinary clinic, turn right out of the driveway and take Shawhan Lane to Kentucky 1893. Turn right (west) on Kentucky 1893 and travel 1.8 miles to U.S. Route 27. Turn right (north) on Cynthiana Road (U.S. 27) and travel about 7.5 miles through Cynthiana to Harrison Veterinary Clinic.

DIRECTIONS TO HOSPITAL

From the trial site to the hospital, turn right out of the driveway and take Shawhan Lane to Kentucky 1893. Turn left (east) on Kentucky 1893 and travel 2.1 miles to Old Ruddles Mill Road. Turn right and then bear right onto Kentucky 1940. After about 2.7 miles, turn left to continue on Kentucky 1940 for 2.8 additional miles, to Millersburg Road (U.S. Highway 68). After 0.3 miles, turn right on Linville Drive, to the hospital on the right.
