We ask the cooperation of exhibitors in helping keep the trial location as clean as possible in order for us to retain the use of this facility for future tests and trials.

No refund for duplicate entries. Every effort will be made to find all duplicate entries, but if an entry has been processed, no refund will be made.

Entries must be received at the Trial Secretary's address by the published closing date to be acceptable, and may not be changed, substituted, corrected, signed, or cancelled after that time except as provided in Chapter 3, section 1, of the General Regulations for Herding Tests and Herding Trials.
